Attended two Fall Area Council meetings (South Central and Northeast) and the State Conference. Extended the term of Vice President one year, 2024. There was no vice president nominee to elect at the 2023 Kansas FCE Annual Conference. This second term started in 2019 (first term was 2012-2015). ANNUAL BUSINESS MEETING: The voting body approved to:

Amend Article VI, Nominations and Elections, Section 1, Nominations, item A. The Bylaw will now read: "Each Area shall elect one member and one alternate to serve on the State Nominating Committee every year at the Fall Area Council meetings for one term beginning January 1. The President shall appoint a former board member as chairman of the Committee. Members of the committee may succeed themselves once."

Accept the 2024 proposed budget.

Elected President-elect Faye Spencer, term 2024, followed by a president's 3-year term. HANDBOOKS – The approved Bylaw amendment changed not only page 10 but two other sections and pages:

Page 10: Article VI – NOMINATIONS AND ELECTIONS, SECTION 1 A, number 1.

Page 20: Area Director: 8. Organize the Fall and Spring Area Council meetings

Page 27: Under "MEETINGS", Area Council shall: item 2b

These pages have been updated and new sheets are to be inserted into existing Handbooks. These corrected pages/sheets are available from the Area Directors and the website. Set your printer to print on both sides. Print pages 9 and 10; pages 19 and 20 and pages 27 and 28. Replace the old with the new pages in all Handbooks.

The 2021 distribution of Handbooks were to officers and other positions with a few sold. That person is to maintain the Handbook and upon their term's expiration, pass on the assigned Handbook to the new officer. DEC 2023

## State EPC - Faye Spencer, Vice President

After all the forms and lessons were printed, I found some errors.

1. Presentation Tabulated Data Report. Strike through the row HF #36 Developing a Dynamic Group.

This is not being offered in 2024 but will be considered for 2025.

2. Community Service Project (green). Strike through 2023 and replace with 2024.

During the State EPC Leadership Training and fall Area Council Meetings of 2024 program year, there were questions/concerns in regards to Accomplishment Reports and 100% Reporting.

Of the 2022 Accomplishment Reports submitted, there were 47 FCE Units, 5 County Councils, and 1 Independent Member. Of the 47 FCE Units, 23 indicated they were to be judged while the other 24 were not to be judged.

How does a county qualify for 100% Reporting?

If <u>all</u> the FCE Units of a county, even if there is only one unit, submits an Accomplishment Report, to be judged or not to be judged, then that county would qualify for 100% Reporting.

What about FCE Accomplishment and/or County Council Accomplishment Reports?

If a County Council submits an Accomplishment Report, that report will be of the ONE lesson that all the FCE Units worked on. All those units would submit that one lesson's data to the County Council EPC, but that one lesson's data *shall not* appear on any of those FCE Unit's Accomplishment Reports.

What if there is only one FCE Unit in the county?

If the unit elects to submit both a FCE Accomplishment Report and County Council Accomplishment Report, the one lesson reported as the County Council Accomplishment Report shall not be re-corded on the FCE Unit's Accomplishment Report.

If there is only one FCE Unit in a county, do the Accomplishment Summary of Award and the 100% Reporting forms need to be completed?

Yes, they do. The Area EPC members will sort all the forms into stacks of like forms. If the Summary and/or 100% are not there, then the process of qualifying for the 100% Reporting may be overlooked for that county.

What if there is an FCE Unit that disbands at the end of the year?

County Council EPC should encourage the unit to complete an Accomplishment Report for the data it may have and the unit may or may not have it judged. Thus, also the county may qualify for 100% Reporting.

If there are any other questions, please contact your Area EPC, State EPC or Vice President.

## National Conference Report Dorene Reimer, Delegate

It was an honor to represent KAFCE at the National FCE Board Meeting in Erlanger, KY, on August 3-6, 2023. The theme of the conference was, "Empowering Volunteers – Celebrating Our Past."

The Conference was a very well organized, and the attendees were attending meetings, dining, or fellowshipping every minute. There were 40 FCE members attending the conference. Ten 1st timers attended the Conference, all from Tennessee.

We arrived for a Wednesday evening Chocolate Workshop—yummm!

I attended the State President/Delegate meeting Thursday afternoon, which provided opportunities to get acquainted with other presidents and delegates from the rest of the states.

Dinner followed for the group as well as an opening reception. Information was presented on "The Family Community Leadership Badge" and how to earn it; classes of chocolate candy making and denim crafts and on the collection of items to be donated to shelters for victims of human trafficking.

Friday, the NAFCE Business Meeting began with the seating of the State Presidents and delegates (11 of 14 states were present) and National Board members.

It seems that Kansas has much representation in the National FCE with three on the Executive Committee, one on the Education Committee, one on the Conference Committee Office, one on Legacy Fund Committee who also is on the Future of FCE Committee.

This year, much work of the National Board and the Future of FCE Committee (of which I am a member) has been about deciding whether National FCE would continue or close down if National FCE can't be sustained. After much discussion, thought, and researching, the Board's conclusion was reached that it would be very complicated, if not almost impossible to not continue National FCE. After that conclusion, the Committee turned its attention to coming up with a list of topics for a nation-wide FCE project of three years duration. Topics the committee presented, a fairly exhaustive list, plus many more topics brainstormed by the groups of attendees in the Saturday afternoon Issue Analysis & Resolution work session, produced the topic of Food Security for the National FCE three-year project, Human Trafficking for a one-year project, and Men's Health for a focus in the future.

The highlight of the Conference for me was being a part of the Saturday afternoon Issue Analysis & Resolution work session. Watching the process used, giving every attendee opportunity for input on the projects National FCE would pursue for the future, was fascinating. It was hard, focused work for about four hours, but gradually the group, all forty attendees, arrived at a common, united resolution. It seemed that resolution arose like a volcano.

The Legacy Fund, established in 2014, was set up to help with the expenses of National FCE. The fund is set up so that only the dividends of the fund can be used to support National FCE. Since its inception, a committee (of which I am a member) has been set up to maintain, encourage and direct the funds within the Legacy Fund. In 2017, there was \$ 31,183.13 in the account. Total donations as of May, 2023, are \$ 63, 346.75. This money has come from donations of various FCE members, non-FCE members, and businesses. Our theme is "Together...We Make a Difference." We were all encouraged to donate, even if only a small amount each year, or larger amounts as we can.

Friday afternoon, two FCL lessons were presented — "Appreciating Generational Differences" and "Music Magic — Therapy for the Soul." All attendees were divided into groups which each prepared a presentation combining the information learned from both FCL lessons. Of course, humor abounded as these skits were presented at the Friday evening FCL banquet. National FCL 30 hour Leader Certifications were awarded to nine women, all from Tennessee. Two other Tennessee women were awarded 60 hour training certifications. The 2023 Spirit of FCL award was earned by Regina McCathern, also from Tennessee!

Saturday morning, two new Hearth Fire lessons were presented—"The Silent Killer — Facts about Ovarian Cancer," and "Family Meals for a Happier, Healthier Family." Workshops were given for each lesson.

At the Saturday luncheon, the 2023 State Heart of FCE winners were recognized and given their pins. I was privileged to accept the pin and certificate for Diana Vancuren, our Kansas Heart of FCE. Both have been sent to her.

One Hundred Year Clubs across the FCE states were recognized. Kansas had two of them: Hodgeman County's Homemakers FCE — March 22, 1922 and Sedgwick County's Viola FCE, 1923.

I received four small booklets in the Delegate bag from Rural Women in Action, an arm of ACWW: CEDAW (The Convention on the Elimination of All Forms of Discrimination Against Women; UDHR-The Universal Declaration of Human Rights); The Convention and Protocol relating to the Status of Refugees; United Nations Declaration on the Rights of Peasants and Other People Working in Rural Areas. An offering was collected for Dollars for Leadership (formerly "Pennies for Friendship) at the Saturday luncheon.

I want to thank KAFCE for sending me to represent the State of Kansas at NAFCE Conference. In my estimation, it was a great working conference which put FCE on a focused future plan. It exemplified the answer to the question, "How do we FCE?"

## Bonnie Teeples, ACWW USA Area President

When I think about going forward in this new Triennia, I am excited about the prospects of each ACWW Society. I hope each society will keep in mind the new Triennial theme 'Sustainable Growth for the Future' when planning the next three years. Think about what the theme means to you, to your societies, and to ACWW. Ask yourself, 'what can I do as an individual to make or encourage sustainable growth in ACWW'?

As the ACWW Area President, I am encouraging each ACWW Society in the United States to work on a nationwide project that has a direct relationship to Food Security. For each of the three triennial years, I will suggest a focus. This year I am focusing on Food Deserts.

I have given presentations about Food Deserts. Since I cannot attend all conferences, I am including a short outline below that you can glean from and help you with a project. If you need more information, please contact me, USA@acww.org.uk.

My hope is that societies will be able to develop a project that can help mitigate food insecurity in their area. If you do a project that has a focus on Food Security (or any of the other resolutions since 1947), I would appreciate it if you would let me know what you did and some information on the project. I will use it when I write my Triennial Report and other reports to the ACWW Board.

#### WHAT IS A FOOD DESERT?

Food deserts are geographic areas where residents have few to no convenient options for securing affordable and healthy foods, especially fresh fruits and vegetables. Disproportionately found in high-poverty areas, food deserts create extra, everyday hurdles that can make it harder for children, families and communities to grow healthy and strong.

WHERE ARE FOOD DESERTS LOCATED? Generally speaking, food deserts are more common in areas with smaller populations, higher rates of abandoned or vacant homes, and residents who have lower levels of education, lower incomes, and higher rates of unemployment.

**HOW ARE FOOD DESERTS IDENTIFIED?** Researchers consider a variety of factors when identifying food deserts, including access to food as measured by distance to a store or by the number of stores in an area; house-hold resources, including family income or vehicle availability; and neighborhood resources, such as the average income and the availability of public transportation.

WHAT ARE A FEW FOOD DESERT SOLUTIONS? Establish bus stop farmers markets. Support community gardens. Improve public transportation options.
